***Student Acceptable Use Agreement for Technology Resources, 2008-2009***

We are pleased to bring Internet access to Analy High School. We believe it offers vast, diverse and unique resources to both students and teachers. Our goal in providing this service is to promote educational excellence by facilitating age appropriate resource sharing and communication that is curriculum based.

**Guidelines/Regulations**

- ◆ **Personal Responsibility:**  
The school has taken reasonable precautions to provide an atmosphere consistent with ethical use. However, the student is responsible for appropriate use of the technological resources.
- ◆ **Student Personal Information:**  
When using the Internet, students may request that return information be e-mailed to them provided they do not provide their home address, telephone number or any other personal information on-line.
- ◆ **Unacceptable Use:**  
This includes, but is not limited to, disseminating derogatory (defamatory, obscene or racist) and/or threatening or harassing language or images, invading the privacy of others, accessing information not part of a school lesson/project, disabling or circumventing the content filter, participating in unauthorized chat rooms, playing computer games, downloading files for personal use, or sharing personal passwords.
- ◆ **Copyright Infringement/Academic Dishonesty**  
It is a violation of school conduct codes to copy text/information and use it in student work without properly attributing the source. Further, it is a violation of Federal law to capture copyrighted data/image(s) and use them without express permission of the copyright holder, except as provided by fair use laws.
- ◆ **Vandalism:**  
Vandalism is defined as any malicious attempt to harm or destroy software, hardware, peripherals, or data. This includes loading/creating computer viruses willful tampering of the operation of the system(s), control panels, and applications, and intentionally circumventing the system protection facilities or engaging in activities that could be interpreted as having this intention.

**Student Agreement** (this signed agreement MUST be on file BEFORE students are granted computer access.) The use of the school technology resources is a privilege, not a right. Inappropriate use will result in the cancellation of those privileges. I understand that if I commit any violation of the regulations, my access to school computer services will be revoked, disciplinary action may be taken and legal referral/action may be pursued. This agreement will be renewed annually.
