

DISASTER CALFRESH IS AVAILABLE **FOR A LIMITED TIME!**

**Applications Accepted October 25 – November 1, 2017,
excluding October 29, 2017 (Sonoma Open on Sunday)**

You may be eligible for Disaster CalFresh if your household:

- Lived in or worked in the disaster area, including Butte, Lake, Mendocino, Napa, Nevada, Sonoma, or Yuba Counties, on October 8; and
- Has experienced a disruption in income; or
- Has damage to your home or self-employment property; or
- Has disaster-related expenses; or
- Has inaccessible liquid resources.
- There is a household income limit

*Those who are ineligible for CalFresh, may be eligible for D-CalFresh. D-CalFresh has fewer verification requirements

*You may be able to purchase hot, prepared food with D-CalFresh benefits at participating stores in the area.

* You could receive **\$192** or more, depending on your eligibility and family size
